5.7 Discussion and action on the Town's contribution towards the El Paso Area Transportation Services, LGC regarding the bus routes for fiscal year 2025. Annete Gutierrez and Xavier Banales with the Rio Grande Government gave a presentation of the town's current agreement with EPATS for FY 2024. The town contributed \$24,100 to ensure the bus routes through the Town would remain in service with EPATS taking over. The contribution for FY 2025 is anticipated to increase to \$30,100. Annete Gutierrez and Xavier Banales gave a presentation on the justification for increasing the fees and how the Town's contribution will be spent. Councilman Weeks motioned to approve, seconded by Mayor Pro Tem Alfaro. Motion passed 5-0.

5.8 Presentation on flock safety for the Town of Anthony, Texas

David and Hector gave a presentation on Flock Safety regarding services and equipment for the Town of Anthony. Chief Enriquez mentioned he applied for a grant by the appropriations act that falls in line to the services equipment provided by Flock Safety.

5.9 Discussion and action on hiring Oscar Gallegos as a police officer for the Anthony Police Department

Chief Enriquez asked Council to allow him to hire Oscar Gallegos as a police officer. Chief Enriquez mentioned he could not continue with the hiring of Mr. Flores and is asking the council to allow him to replace Flores with Gallegos. Councilman Chavez motioned to approve, seconded by Councilman Weeks. Motion passed 5-0.

6.1 Public Works Department- Mark with Parkhill, gave a thorough report on the

water and sewer plants.
