A RESOLUTION OF THE TOWN OF ANTHONY, TEXAS, HEREINAFTER REFERRED TO AS "APPLICANT," DESIGNATING CERTAIN OFFICIALS AS BEING RESPONSIBLE FOR ACTING FOR AND ON BEHALF OF THE APPLICANT IN DEALING WITH THE TEXAS PARKS AND WILDLIFE DEPARTMENT, HEREINAFTER REFERRED TO AS "DEPARTMENT," FOR THE PURPOSE OF PARTICIPATING IN THE <u>LOCAL PARK GRANT</u> <u>PROGRAM</u>, HEREINAFTER REFERRED TO AS "PROGRAM" ; CERTIFYING THAT THE APPLICANT IS ELIGIBLE TO RECEIVE PROGRAM ASSISTANCE; CERTIFYING THAT THE APPLICANT'S MATCHING SHARE IS READILY AVAILABLE; AND DEDICATING THE PROPOSED SITE FOR PERMANENT PUBLIC PARK AND RECREATIONAL USES.

WHEREAS, the Applicant is fully eligible to receive assistance under the Program; and

WHEREAS, the Applicant is desirous of authorizing an official to represent and act for the Applicant in dealing with the Department concerning the Program,

BE IT RESOLVED BY THE APPLICANT:

- Section 1: That the Applicant certifies that it is eligible to receive assistance under the TRPA Program; and that notice of a grant application has been posted according to local public hearing requirements.
- Section 2: That the Applicant hereby certifies that the matching share for this application is readily available at this time.
- Section 3: That the Applicant hereby authorizes and directs the Mayor to act for the Applicant in dealing with the Department for purposes of the Program, and that the Mayor is hereby officially designated as the representative in this regard.
- Section 4: That the Applicant hereby specifically authorizes the official to make application to the Department concerning the site to be known as Rainbow Lake Community Park and, upon completion of the proposed acquisition, will be dedicated for public park and recreation purposes in perpetuity.
