All agenda items are subject to action. The Town of Anthony Council reserves the right to meet in a closed session for consultation with the Town Attorney on any agenda item should the need arise and if applicable pursuant to authorization by Title 5, Chapter 551, of the Texas Government Code.

1.0 CALL TO ORDER- Mayor called meeting to order at 5:33pm.

3.0 PLEDGE OF ALLEGIANCE- Mayor Turner led the Pledge of Allegiance.

4.0 PUBLIC COMMENTS AND RECEIPT OF PETITIONS: [At this time, anyone will be allowed to speak on any matter other than personnel matters or matters under litigation, for length of time not to exceed two minutes. No Council discussion or action may take place on a matter until such matter has been placed on an agenda and posted in accordance with law – GC, 551.042.]

Resident Irene Briseno 3031 Myriam St had concerns that her back yard is connected to the NM desert and there has been more target shooting happening. Another concern was that her

neighbor has currently 4 dogs and doesn't pick up after their dogs. Another of her concerns was that there has been 18 wheelers cab parking in the neighborhood and thinks is not safe and creates a lot of pollution because they are left on for a while.

5.0 Approve the Minutes of the following Town of Anthony Council Meetings:

07-22-2024 Regular Town Council Meeting

Councilwoman Stevens motioned to approve 07-22-2024 Regular Town Council Meeting minutes, seconded by Mayor Pro Tem Alfaro. Motion passed 4-0.

6.0 Old Business:

6.1 Discussion, consideration, and action a resolution of the Town of Anthony, Texas adopting budgment amendment no. 2023-05-0925 amending the municipal budget for fiscal year 2024 reduce the contingency account (6166) by \$10,000.00 to provide additional funding for repairs and maintenance of vehicles (6130) in the amount of \$3,000.00; to provide additional funding for advertising the food truck park (6138) in the amount of \$1,000; and additional funding for employee uniforms (6161) in the amount of \$6,000.00

Councilman Chavez was concerned since money needs to be moved, he thinks the town is not budgeting enough for repairs and maintenance of vehicles. Councilman Chavez states that since the new budget is coming up it would be a great time to budget properly. Mayor Turner stated that last year the budget had to be made based on the numbers from the previous year. Councilman Chavez also stated that transferring money to employee uniforms is a lot. Chief Enriquez stated since public works has had a turnover with employees he needs to continuously be getting new uniforms and the company currently being used for uniforms have increased their fees too. Councilwoman Stevens motioned to approve the transfers, seconded by Councilman Weeks. Motion passed 4-0.

6.2 Discussion, consideration, and action on a resolution of the Town of Anthony, Texas adopting budgment amendment no. 2023-05-0925 2 amending the municipal budget for fiscal year 2024 to reduce the quality of life events account (6193) by a total \$52,450.00 to provide additional funding for contingency account (6166) in the amount of \$40,000.00; and to provide additional funding to Texas Municipal League Intergovernmental Risk Pool ("TMLIRP") (6110) in the amount of \$12,450.00.

Mayor Pro Tem Alfaro motioned to approve, seconded by Councilwoman Stevens. Motion passed 4-0.

7.0 New Business:

7.1 Presentation of Tax Rolls and 2024 Tax Rate Calculation Worksheet and action to authorize the staff to publish the intended Tax Rate for FY 2025

The Accounting Manager went over last year's approved tax rate. Accounting Manager went over the no new revenue rate, voter approvals rate, and the de minimis. The accounting manager mentioned that to be in compliance with law requirements it needs to be published. The accounting manager asked the council for publishing purposes to vote for the De minimis rate and can always be adjusted. 7.2 Discussion and action regarding Proposed FY 2025 Budget and Tax Rate.

Councilman Chavez motioned to approve the De Minimus tax rate, seconded by Councilman Weeks. Motion passed 4-0.

7.3 Discussion and action regarding dates for adoption of Budget and Tax Rate.

The Town Clerk mentioned this is to publish the dates for adoption of Budget and Tax Rate which will be published on August 22,2024 with West Texas County Courier and September 9, 2024 will be the adoption date. Councilwoman Stevens motioned to approve the publication for public hearing on August 22,2024 and September 9, 2024 regular town council meeting for the adoption tax rate, seconded by Councilman Chavez. Motion passed 4-0.

7.4 Discussion, consideration and action on terminating services with the County of El Paso Animal Welfare

Mayor Turner discusses this is a proposal budget aspect as the County fees are going up. The Mayor is planning on hiring and implementing its own animal welfare unit to service the Town of Anthony. The money allocated to El Paso County will be used to offset the salary of a new animal control unit. Chief Enriquez mentioned that the police officers are currently having to pick up the animals and take care of them because animal welfare can't take them. Councilwoman Stevens motions to table terminating services with the County of El Paso Animal Welfare, seconded by Councilman Weeks. Councilman Chavez Nay. Motioned passed 3-1.

7.5 Discussion and action regarding an Order calling a special election on Tuesday November 5, 2024, to consider the adoption of a Home Rule City Charter.

The Town Attorney states that the deadline is coming up to call an election for Tuesday November 5,2024. Councilman Weeks states that the Charter Committee has not met yet and states it might not work because they have less than three months to present it to the public and have vote on November 5th 2024. Councilman Chavez motions to approve, seconded by Mayor Pro Tem Alfaro. Councilman Weeks no. Motion passed 3-1.

7.6 Discussion and Action on a Resolution authorizing the Mayor to sign a contract with the County Election Administrator to conduct Charter Election on November 5, 2024.

The Town Attorney mentioned this is to authorize Mayor to sign the contract with the County Election Administrator to conduct the Charter Election for \$5,669.46. Councilman Chavez motioned to approve, second by Councilwoman Stevens. Councilman Weeks opposed. Motion passed 3-1.

7.7 Discussion, consideration and action on selecting the medical plan with Curative, the dental plan with Guardian, the vision plan with Guardian, and basic life and accidental & dismemberment plan with Hartford for fiscal year 2025

Chief Enriquez mentioned that the Town went into the RFQ process for new brokers. The current broker is not meeting the Town's standards that the Town requires. USI was the selected brokers; they came and made a full census from the Town of Anthony employees. USI came back with several options and the best option that will be beneficial for employees is Curative. The benefit to employees is that the monthly contribution from the Town would be an identical match or a couple of dollars less. For the Dental and Vision plan the best option would be Guardian and these plans would be extra cost for the employees. Also, Hartford was selected as the life insurance that was most beneficial for the town employees. Councilman Stevens motioned to approve, seconded by Councilman Chavez. Motion passed 4-0.

7.8 Discussion, consideration and action on interlocal agreement between Town of Anthony, Texas and City of El Paso, Texas for animal services for fiscal year 2025 Mayor Turner discussed this is the contract that the Town originally had before and are going up on their rate. Chief mentions that the fee for dogs and cats is \$60.00 and it will go up to \$110 plus an everyday fee for having them in their kennels. Councilwoman Stevens motioned to approve the contract with the City of El Paso, seconded by Mayor Pro Tem Alfaro. Councilman Chavez nay. Motion passed 3-1.

8.1 Public Works Department- Isael the Public Works Superintendent gave a report on the

water and sewer plant. Along with the parks and streets.

8.2 Finance Department- Nothing to report.

8.3 Anthony Police and Municipal Court Department- Nothing to report.

8.4 Administration Department - Mayor Turner mentioned that a Master Fee Schedule is

currently being made. And mentioned that the Twilight Farmers Market was a success.
