

**ORDINANCE: 2016-0328**

**AN ORDINANCE OF THE TOWN OF ANTHONY, TEXAS AMENDING THE TRUCK ROUTES ORDINANCE NO. 421 BY AMENDING THE TRUCK ROUTES SECTION TO EXTEND THE TRUCK ROUTE EASTBOUND FROM FOURTH STREET TO 908 FRANKLIN STREET FOR LOCAL DELIVERIES ONLY.**

**WHEREAS**, the GOVERNING BODY did hold a duly noticed Public Hearing; and

**WHEREAS**, the GOVERNING BODY did consider testimony from staff and the public before reaching its decision; and

**WHEREAS**, pursuant to the statutory authority granted to the GOVERNING BODY as a municipality under Texas Local Government Code Section 51.001, the GOVERNING BODY may adopt, publish, amend, or repeal an ordinance, rule, or police regulation that: (1) is for the good government, peace, or order of the municipality or for the trade and commerce of the municipality; and (2) is necessary or proper for carrying out a power granted by law to the municipality or to an office or department of the municipality; and

**WHEREAS**, pursuant to the statutory authority granted to the municipality as a Type A General-Law Municipality under Texas Local Government Code Section 51.012, the municipality may adopt an ordinance, act, law, or regulation, not inconsistent with state law, that is necessary for the government, interest, welfare, or good order of the municipality as a body politic; and

**WHEREAS**, the GOVERNING BODY does make the following finding:

1. That it is in the best interest of the public at large and to otherwise safely and efficiently regulate the travel of trucks within the municipal limits of the Town of Anthony, Texas that the truck routes be extended eastbound from Fourth Street to 908 Franklin Street for local deliveries only.

**BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF ANTHONY, TEXAS:** that in consideration of the aforementioned findings and testimony, it hereby ordains that it does hereby approve the extension of the truck routes eastbound from Fourth Street to 908 Franklin Street for local deliveries only:

**Section 1. AUTHORITY AND PURPOSE.**

**AUTHORITY:** This Ordinance is adopted pursuant to the enabling provisions of Texas Local Government Code Section 51.001 and Section 51.012.

**PURPOSE:** The purpose of this ordinance is to amend the truck routes section of the Truck Routes Ordinance No. 421 for purposes of extending the truck routes eastbound from Fourth Street to 908 Franklin Street for local deliveries only.

**Section 2. AMENDMENT OF TRUCK ROUTES SECTION OF THE TRUCK ROUTES ORDINANCE NO. 421.**

The truck routes section of the Truck Routes Ordinance No. 421, which currently reads as follows:

**“TRUCK ROUTES:**

The following streets, as designated herein below, are hereby established as truck routes:

1. FM 1905: from Interstate 10 frontage road; Desert North to Wildcat DR.
2. Wildcat DR (Spur 6): from FM 1905 to main street (SH 20)
3. Main Street: From Stateline on State Highway (SH 20) to the city limits on the southwest side of Anthony, Texas”

**is hereby amended to read as follows:**

**“TRUCK ROUTES:**

The following streets, as designated herein below, are hereby established as truck routes:

1. FM 1905: from Interstate 10 frontage road; Desert North to Wildcat Dr.
2. Wildcat Dr. (Spur 6): from FM 1905 to Main Street (SH 20)
3. Main Street: from Stateline on State Highway (SH 20) to the city limits on the southwest side of Anthony, Texas
4. Fourth Street: from Fourth Street to 908 Franklin but for local deliveries only

**Section 3. SEVERABILITY.**

Should any section, paragraph, clause or provision of this Ordinance for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section,

paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

**Section 4. REPEALER.**

All ordinances or resolutions or parts thereof, inconsistent with the provisions of this Ordinance are hereby repealed to the extent only of such inconsistency or conflict. This repealer shall not be construed to revive any ordinance or resolution or part thereof, heretofore repealed.

**Section 5. EFFECTIVE DATE.**


This ordinance shall be effective as provided by law.
