### **Rentals & reservations**

#### Purpose

The Town of Anthony has made some park amenities and athletic fields available for rental to individuals, groups, and organizations residing within the Town of Anthony, Texas to create an additional boost to the local economy and to help cover for maintenance costs.

Priority for use will be given to year-round recreational programs directly sponsored and/or co-sponsored by the Town of Anthony.

#### **Application Process**

4. Once payment is received, a permit will be issued. A copy of the permit should be available to display to any law enforcement official or personnel upon request.

#### **TERMS AND CONDITIONS**

It is the responsibility of the permitted User to abide the following terms and conditions:

- The permit is valid for the date, location within the park and group size as indicated at the time of purchase. Permit is not valid for the entire park.
- The Renter needs to plan for set-up time and clean up time within that time slot.
- All Renters shall leave Venue in the same condition as arriving by placing all litter in designated trash receptacles or area, removing all decorations, personal items, etc.
- Renters are responsible for cleaning up all areas which, because of use, require more than normal clean up, i.e., excessive bathrooms or picnic trash.
- An additional fee shall be assessed to the Renter for any clean-up which is more than normal facility use.
- Should there be any damages, the Renter shall be invoiced for the additional charges, due within ten (10) days after receipt of notification.
- Park rules must be always obeyed.
- Park hours must be observed.
- No vehicles allowed in picnic areas. Vehicles must remain in parking lots and in designated parking areas.
- The Town of Anthony assumes no responsibility or liability for harm, injury, or any damaging events which are directly or indirectly attributable to premises defects which may now exist, or which may hereafter arise upon the premises, any and all such defects being expressly waived by Renter.
- PERMIT MUST BE READY FOR DISPLAY AT THE SITE DURING USE. PERMIT HOLDERS DOES NOT NEED TO BE PRESENT TO DISPLAY PERMIT WHEN ASKED FOR BY CODE ENFORCEMENT, LAW ENFORCEMENT OR ANY OTHER TOWN OFFICIAL.
